The following terms and conditions of eir.ie ("Terms of Use") apply to users, viewers and all people who have access to eircom Limited's web sites located at [www.eir.ie](http://www.eir.ie) and [www.myeir.ie](http://www.myeir.ie). By using and viewing eir's web sites, you agree to these Terms of Use. If you do not agree, do not use our web sites. Any access or use of eir's web sites is undertaken at your own risk.
