Aoife Beirne

Aoife Beirne is the Chief Transformation Officer and Director at Mergon Group, leading the strategic transformation across the organisation, and focusing on long-term strategy, culture and growth of the organisation. Aoife was formerly Chief of Staff at An Post, working alongside the CEO and management board delivering the strategy which transformed the organisation from loss-making to profitability and growth. Aoife also spearheaded and launched the first An Post gender pay gap report in 2019. Aoife holds an MBA from UCD Smurfit Business School, a Diploma in Psychology from DBS, a Higher Diploma in Quality Assurance from NUI Galway, and a BSC Double Honours in Science from NUI Maynooth.

eir is the largest provider of fixed line telecommunications services in Ireland, offering broadband, voice, TV, data services as well as networking, security and managed services to residential, small business, enterprise and government segments.

eir is the third largest mobile operator in Ireland in terms of revenue and customers. The company operates the eir mobile and GoMo services. The Group generated total revenue of more than €1.2 billion and adjusted EBITDA of €600 million for the year ended 30 June 2020.

eir's wholesale division, open eir, is the largest wholesale telecommunications operator in Ireland, providing products and services to national and international wholesale customers across a range of regulated and unregulated markets.
