



Association of eircom Pensioners Offer Terms and Conditions 2020

1. To avail of the offer which is made available to members of the Association of eircom Pensioners as set out in our advertisements you must qualify for eir Broadband (the “Association of eircom Pensioners Offer”). An eir Talk package excluding eir Talk Pay as You Use is also required to avail of the Association of eircom Pensioners Offer.
2. To avail of this Association of eircom Pensioners Offer you must be a member of the Association of eircom Pensioners and the account must be in the name of the member.
3. The Association of eircom Pensioners Offer will be available until 31/03/2020 or as otherwise notified by eir.
4. eir reserves the right at its own discretion and as the need may arise at any time before that date to remove, withdraw, suspend, terminate, modify or alter the Association of eircom Pensioners Offer.
5. If you choose to avail of the Association of eircom Pensioners Offer it will be necessary for you to set up Direct Debit payment.
6. In the event you still have eir Basis A/B allowances for whatever reason, such allowances cannot be kept when availing of the Association of eircom Pensioners Offer.
7. eir broadband and eir fibre, are subject to availability. To check for eir broadband and eir fibre availability visit <https://www.eir.ie/broadband/coverage-map/>.
8. eir TV and eir TV add ons are an additional cost per month to the cost of the Association of eircom Pensioners Offer. eir TV is subject to availability and requires eir Fibre.
9. The Association of eircom Pensioners Offer installation is free of charge for eir broadband (non-fibre) and eir fibre FTTC (fibre to the cabinet) customers. For FTTH (fibre to the home) customers a once off installation fee of €99 will apply.
10. eir has the right to reject your order.
11. The Association of eircom Pensioners Offer bills will be issued monthly.
12. Members of the Association of eircom Pensioners availing of this Association of eircom Pensioners Offer will receive eir broadband or eir Fibre broadband for €39.99 a month for life. This means eir will not be changing the price of the eircom Pensioners Offer.
13. For members of the Association of eircom Pensioners who also include mobile as part of the offer they will receive a €10 monthly discount on each eir mobile plan promotion in their bundle for 24 months. After 24 months, standard pricing will apply on mobile plans. Members of the Association of eircom Pensioners can also avail of a standalone 24 month

eir mobile bill pay plan and such members will receive a €10 monthly discount for the 24 month period.

14. All promotions under the Association of eircom Pensioners Offer are subject to availability. Handsets are subject to availability and prices may vary. A once off charge made by credit or Visa Debit card for deposit may be required. Visit www.eir.ie/mobile for full prices
15. Fair usage policies apply to unlimited components of fixed and mobile plans. See www.eir.ie.
16. The minimum term of a bundle will be 12 months for fixed services, 24 months mobile handset plans, and 30 day minimum term contract for SIM Only plans. SIM Only discount is only available as part of a bundle with fixed services.
