

Terms for eir Mobile prepay offer Thirty20 free on net talk, text and landline

1. These terms and conditions of Thirty 20 – eir Mobile to eir Mobile Talk and Text and Free Calls to Landlines offer (the “Offer”) are in addition to the Terms and Conditions of the eir Mobile Service. In the event of any conflict, these terms and conditions will prevail. By registering for the Offer and each time you top-up your account to continue to avail of the Offer, you acknowledge and accept these terms and conditions.
2. The Offer is available only to Prepay Customers who are on a Variety Plan (“Eligible Customers”). Eligible Customers must register for the Offer by free texting the word “Talk & Text” to 50104. Eligible Customers must then top-up by €20 or more in one go to avail of the Offer.
3. The Offer is subject to fair use limit of 5000 minutes of calls to eir Mobile and Meteor customers and 5000 texts to eir Mobile and Meteor customers and 40,000 minutes to any landline in the Republic of Ireland for use within thirty days (the “Fair Usage Policy”). All calls made by customers to eir Mobile and Meteor customers and to landlines are free for a maximum duration of 60 minutes. Any usage exceeding this limit will be charged at standard rates, the details of which can be found on www.eir.ie/pricing.
4. Once registered for the Offer, Eligible Customers will receive the free calls to landlines, subject to the Fair Usage Policy, for a period of 12 months only which will commence from the date of the next €20 top-up after first registration of the Offer and subject to continuing to top-up in accordance with the Offer.
5. Thirty 20 Talk &Text customers before the Launch Date will receive the free calls to landlines automatically, subject to the Fair Usage Policy, for a period of 12 months from the date of the next €20 top-up after the Launch Date and subject to continuing to top-up in accordance with the Offer.
6. Once an Eligible Customer is registered, a minimum of €20 top up every thirty days is required to continue to avail of the Offer. If an Eligible Customer does not have a minimum of €20 credit available on the account at the end of the thirty day period to extend the Offer for another thirty days, the Eligible Customer will be charged at the standard rates. Once the Eligible Customer tops up by €20 or more, the Offer is re-activated.
7. An automatic reminder will be sent via SMS to customers on day thirty to remind the Eligible Customer to top up to continue to avail of the Offer. eir Mobile does not warrant or represent that it shall send such a reminder and it shall not be responsible for any liability incurred by a Customer as a result of its failure to do so.
8. Eligible Customers should allow a maximum of up to one working day after topping up for the Offer to take effect.
9. The minutes and texts under the Offer must be used within thirty days. Unused minutes and texts cannot be carried over from one thirty day period to the next.
10. This Offer does not include: Usage when roaming outside of the EEA, see www.eir.ie/pricing for more information on fair use allowances, applicable countries and pricing; SMS sent to international numbers, Multimedia Message Service (MMS) messages and calls made to premium rate and non-geographic numbers. SMS sent to landlines must be to landline numbers capable of receiving SMS messages.

11. Eligible Customers may only register for one Offer at any one time. Eligible Customers can switch from this Offer to any other variety offer by texting the relevant key word to short code 50104 or on myeirmobile.ie. Once the Eligible Customer has registered for another offer, the Eligible Customer will cease to avail of the benefits associated with the previous Offer. Eligible Customers can move from Variety to Variety Plus by calling 1749 or on myeirmobile.ie.
12. Customers may terminate their subscription to the Offer by calling 1749. In the event that the customer terminates the Offer, the Eligible Customer will be charged at the standard rates.
13. By registering for the Offer, you consent to eir Mobile contacting you by SMS to notify you of successful or unsuccessful registrations, activations, updates, changes in relation to this Offer for as long as you remain on the Offer. eir Mobile does not warrant or represent that it shall send such SMS messages and you acknowledge that it is not bound to do so.
14. eir Mobile reserves the right to vary or amend these terms and conditions or withdraw the Offer in whole or in part at any time.
15. Except as expressly provided in these terms and conditions, all conditions, terms, warranties and representations whether express or implied by law in relation to the provision of the Offer are excluded to the fullest extent permitted by the applicable law.
