

Bill Pay Data Add-On

The following terms and conditions form part of eir's Mobile Internet Add-On bundle service ('Mobile Internet Add-On Bundle' / 'the Service'). eir's general terms and conditions, to which you have also agreed to, and eir's Fair Usage Policy ('FUP') both of which are available at <https://www.eir.ie/termsandconditions>, combined with these terms below constitute a legally binding agreement between eir ('we/us', 'eir') and the Customer ('you/the Customer') for the use of the Service. All capitalised terms herein (unless otherwise defined) shall have whatever meaning is ascribed to them in the general terms and conditions.

Mobile Internet Add-On Bundles are open to new and existing Bill Pay Customers. Please see eir.ie/mobile or a full list of the eligible tariff plans which the Mobile Internet Add-On Bundles are available on. A Mobile Internet Add-On Bundle consists of an optional addition to the price of your Bill Pay Tariff Plan of the given amount of data MB's per month.

Mobile Internet Add-On Bundles are applied to selected individual (subscriber-level) accounts and may not be applied to client-level accounts. Only one subscription per subscriber will be allowed.

Customers availing of a Mobile Internet Add-On Bundle hereby agree, by availing of this Service, that eir may contact them, on an ongoing basis, specifically in relation to this Service.

Mobile Internet Add-On Bundles are restricted to personal use only. eir reserves the right to withdraw or terminate this service without notice should eir reasonably believe, at its' sole discretion, that the Service is being used for commercial purposes. eir shall not be liable for any loss or damage, direct or indirect, howsoever arising from the withdrawal, termination, amendment of Mobile Internet Add-On Bundles or otherwise in relation to the Service.

Following successful registration to subscribe to receive Mobile Internet Add-On Bundles, your subscription to the Service will take effect within 24 hours. Should the eir Mobile Internet Add-On be activated mid-month the cost will be pro-rated on your bill.

You will receive a Mobile Internet Add-On Bundle provided your eir Mobile Bill Pay account is not terminated or suspended or until you request that eir cancel your subscription.

You may terminate your subscription to Mobile Internet Add-On Bundle at any time provided you give eir at least 3 working days' notice prior to their next billing date for such termination to take effect. Termination of the Service will then take effect on your next Billing Date.

Mobile Internet Add-On Bundles will be deducted from your account before any other Mobile internet bundle that may come with your Tariff Plan. Once you have used up all the Mobile Internet Add-On Bundle, all subsequent data will be charged at eir's standard rates as per the Customer's given Tariff Plan. eir's standard rates are available at <https://www.eir.ie/mobile>

Mobile Internet Add-On Bundles expire at the end of each billing cycle. No balance of any unused Mobile Internet Add-On Bundle can be carried over from one billing period to the next. You will forfeit any unused portion of the Data Add-On Bundle.

Mobile Internet Add-On Bundles cannot be used whilst roaming outside of the Republic of Ireland. eir reserves the right to vary or amend these terms and conditions of the Service in whole or part at any time, where in its opinion there is a valid commercial, technical or operational reason. eir will endeavour to give you reasonable prior notice of any changes to the Service, or its terms and conditions, however
