

Notes:

- 1 This Free Tablet Offer is only open to residents of the Republic of Ireland who are over 18 years of age.
- 2 The eir tablet voucher is emailed to the customer once the customer (1) purchases a qualifying bundle, (2) has their bundle installed and activated and (3) passes the 14 day cooling off period for the bundle; there is a maximum of one voucher per customer.
